

Time will be 90 seconds. There will be a buzzer at 70 seconds as a warning, and the final buzzer at 90 seconds. Toys & food **can be used** during the fun run. Toys containing food cannot be used unless empty and clean.

*Preferred From Toronto and 400 North:

Exit left onto Mapleview Dr. Go west (turn right) onto Town Line Rd. (CR 27). Turn left into RBEC.If you get to lights at Ardagh, you've gone too far. Some GPS says it is on right – they are wrong!

From CR 27 South: Follow CR 27 northbound through Thorton. Continue north. After 5 minutes, look for signs on your right that show you have to turn LEFT to stay on CR 27. When you see that sign, turn left, continue on CR 27. When you come down the big hill lookfor our white flags on the west (left) side of the road.
